Dear Mr. Bagley:

We received sworn complaint SC-2804199 on April 15, 2008. This complaint meets the technical form requirements for a complaint filed with the Texas Ethics Commission, and the executive director has determined that the Ethics Commission has jurisdiction over the violations of law alleged in the sworn complaint. The complaint alleges that the respondent failed to properly report loans on his January 2008 semiannual campaign finance report, in violation of section 254.031 of the Election Code. The sworn complaint will be processed as a Category One violation.

The complaint also alleges that the respondent failed to timely file his July 2007 semiannual campaign finance report and failed to properly notarize his July 2007 semiannual campaign finance report. The Ethics Commission has previously made the respondent aware of those errors related to his reports. The respondent has satisfactorily addressed those errors. Therefore the allegations related to those errors will not be considered.

The law requires the commission to mail certain notices relating to a sworn complaint to the respondent and the complainant. The notices are required to be sent by registered or certified mail, restricted delivery, return receipt requested unless the requirement is waived by the respondent or complainant. The enclosed form may be used to submit a waiver.

Please note that at this stage in the process, Ethics Commission members and staff are required by law to keep the complaint and all documents relating to it strictly confidential. However, other persons, including the complainant and respondent named in the complaint, are not bound by this confidentiality requirement.

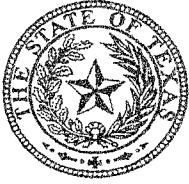

He further stated, "All this has been corrected." However, by submitting his campaign finance report on August 6, 2007 (three weeks late), Mr. Tough failed to timely file his July 2007 semiannual report. In addition, he submitted this report without the required notary witness.
